I am submitting my name for consideration for election to the Gainey Ranch Community Association Board of Directors.

I was a part-time resident of the Gainey Ranch community starting 2003 after purchasing a home in Arroyo Vista located on Arroyo 7. In 2013, I moved to The Legend and am now living on Lakes 7. In mid-2016, I became a resident of Arizona and live here on the Ranch full-time.

Although I was born in Chicago, I grew up in Billings, Montana. I moved to Denver, Colorado in 1967 to attend the University of Denver, graduating with a BSBA (Accounting) in 1971.
